**Course Description**: Stormwater runoff from impervious surfaces causes both water quality and quantity challenges for CT municipalities. Green Stormwater Infrastructure practices help communities address those problems by seeking to infiltrate stormwater into the ground close to where it falls rather than runoff into the stormwater system. In this independent study, students will apply concepts and methods learned in the Spring Semester 2022 course "Green Stormwater Infrastructure Practices" to conduct stormwater retrofit assessments and regulation reviews for CT municipalities.

#### Learning Objectives (depending on project type):

- Identifying potential properties for stormwater retrofits
- Assessing properties for opportunities to use Green Stormwater Infrastructure practices to infiltrate stormwater
- Developing recommendations for municipalities for potential stormwater retrofit projects including proper siting, sizing, cost estimates, and impacts on pollutant load reduction
- Professional presentation of recommendations both orally and in written form
- Understanding the constraints and benefits facing municipalities when implementing retrofit projects
- Working effectively on a team project
- Professional communication, project management, and organizational skills
- Assessing land use regulations

#### **Course Requirements**

Meeting times to be determined. The Stormwater Corps will meet once per week for one hour with the instructors. We will meet as a group, as well as in individual teams, during this time. Additional meetings or discussions can be set up as needed. Weekly meetings with instructors will focus on student progress towards responsibilities, deliverables and learning objectives. Email will be used as a primary means of communicating with town staff. Timely communication is important!

Students will also need to meet and communicate with team members on a regular basis, participate with team members in online meetings with town staff, and conduct site visits to towns.

#### Deliverables

Deliverables will include the following for a municipality:

- 1. Identification and preliminary design of potential sites for stormwater retrofits
- 2. Review of municipal land use regulations for water quality protection
- 3. Presentation of recommendations to municipal staff in a virtual/online meeting
- 4. Written report with recommended designs, impact calculations, and land use regulation review

For team project deliverables: Each student is responsible for completing their fair share of the project work and deliverables. Achievement will be determined by a combination of peer assessment and instructor observation.

Grading of reports and presentations will be based on quality of recommendations, effectiveness in conveying those recommendations, attention to detail in presentations and reports, proper calculations of costs and impacts, and quality of review of land use regulations consistent with the Codes and Ordinances Worksheet.

#### Student Responsibilities and Resources
